Dear Valued Customer:

Sadly, it is coming to that time of the year again, Winter Storage. Please find enclosed our storage contract. Please take a few moments to review our policies and pricing.

This year we are limited on storage so it is on a first come basis. All storage contracts must be returned by **September 18, 2017** along with your insurance documents and your check. Your check is used to hold your spot for winter storage. Full payment is required upon signing this contract and is non-refundable. You must contact us prior to June 1, 2018 to let us know what your plans are for launching or summer storage. **It is your responsibility to contact us. All boats must be removed from storage no later than June 1, 2018 or a \$50.00 per day fee will be charged, there will be no exceptions.** We will require at least a 4 week notice for all spring work, boat delivery and launching.

1. Make checks payable to “Archery Solutions”;
2. Provide copy of boat insurance with coverage up **to June 1, 2018 – you can call your insurance carrier and request this date on your insurance document;** and
3. Fill out, sign and return the attached contract by September 18<sup>th</sup> to the address above. **SUBMIT ALL PAPERWORK AT THE SAME TIME. All communications regarding storage or winterization must come through the office at 265-3333.**
4. All boat bottoms must be clean prior to entering indoor storage.

It is the responsibility of the customer to check over their property when delivering or picking up their watercraft at either our shop or at a marina. Once customer has taken possession of their watercraft, we are no longer liable for any damages or lost property. It is also the customer’s responsibility to check over their slip for dock lines, power cords, etc., as M&M will accept no liability. We have also enclosed the 2017 Winterization Contract. Please fill this out and return to us. **No work orders will be taken for anyone that has an outstanding balance.**

If you do not return your paperwork by **September 18, 2017**, we will move on to our waiting list.

Under no circumstances will any outside vendor be allowed to work on your boat. **Any boats left after 6/1/18, will be charged a fee of \$50 per day until the boat is picked up.**

M & M Lakeside Marine and Archery Solutions will not be responsible for any losses or damages, theft, or vandalism to any property including boats, trailers or personal property. We will notify Owner at the phone numbers listed above if any unusual circumstances arise. A letter will be mailed if we cannot reach you by telephone.
