Dear Valued Customer:

Sadly, it is coming to that time of the year again, Winter Storage. Please find enclosed our storage contract. Please take a few moments to review our policies and pricing.

This year we are limited to 50 spots so it is on a first come basis. You will secure a spot only by returning all your documents, signed, along with your check by September 18<sup>th</sup>. You may also call in a charge card. Your payment is used to hold your spot for winter storage. A 50% deposit for storage is required upon signing this contract and is non-refundable. You must contact us prior to **April 30, 2018**, to let us know what your plans are for launching or summer storage. **It is your responsibility to contact us. All boats must be removed from storage no later than May 15, 2018 or a \$50.00 per day fee will be charged by, there will be no exceptions.** We will require at least a 4 week notice for all spring work, boat delivery and launching.

1. Make checks payable to “M&M Lakeside Marine”
2. Call and give us a charge card
3. Fill out, sign and return the attached contract by **SEPTEMBER 18, 2017.**

Return the entire package to our address above. Please submit all items at the same time.

IN THE SPRING, YOU CANNOT PUT YOUR SHIRNKWRAP IN SOUTHPOINT'S DUMPSTER. You must dispose of it yourself if you are removing your own shrink-wrap. A \$150 fee will be imposed on anyone who puts their shrink-wrap in South Point's dumpster payable to SP Marina.

It is the responsibility of the customer to check over their property when delivering or picking up their watercraft at either our shop or at a marina. Once customer has taken possession of their watercraft, we are no longer liable for any damages or lost property. It is also the customer's responsibility to check over their slip for dock lines, power cords, etc., as M&M will accept no liability. **No work orders will be taken for anyone that has an outstanding balance.**

If you do not return your paperwork by **September 18, 2017,** you will lose your storage spot as we have an existing waiting list

We will notify Owner at the phone numbers listed above if any unusual circumstances arise. It is your responsibility to carry insurance. A letter will be mailed if we cannot reach you by telephone.
